

A Temporary Protective Order (TPO) is a civil order issued by a Superior Court Judge for the protection of victims of Family Violence and/or Stalking. Pursuant to O.C.G.A. 19-13-4, a Temporary Protective Order can:

- **Direct abuser to stop abusing, harassing, & intimidating victim and/or victim's minor children**
- **Stop abuser from having any direct or indirect contact with the victim and/or victim's minor children**
- **Forbid the abuser from approaching within 150 yards of victim and/or victim's minor children, home, work, or school**
- **Award temporary custody of minor children to the victim**
- **Remove abuser from the family residence**
- **Grant victim exclusive temporary use and possession of the family residence if desired or permission to remove personal property for victim and minor children**
- **Grant victim temporary use of automobile**
- **Remove weapons from the abuser**
- **Direct law enforcement to enforce the conditions of the TPO Order**

FAMILY VIOLENCE MEANS:

Any offense of battery, simple battery, simple assault, stalking, criminal damage to property, unlawful restraint, criminal trespass between past or present spouses, mutual parents of a child, parent and child, persons who are or have lived together in an intimate relationship

DEFINITION OF STALKING:

A person commits the offense of stalking when he or she follows, places under surveillance or contacts another person at or about a place or places without the consent of the other person for the purpose of harassing and intimidating the other person. The term contact shall mean any communication including communication in person, by telephone, by mail, by email, by fax, by third party

ARRANGE TRANSPORTATION TO A SHELTER OR SAFE PLACE

EXECUTE WARRANTS TO PROSECUTE OFFENDER, OR DIRECT YOU TO MAGISTRATE COURT IF APPROPRIATE

ADVISE YOU OF YOUR OPTIONS

FURNISH INFORMATION ON LOCAL SHELTERS

ADVISE YOU ON PROCEDURES FOR OBTAINING A TEMPORARY PROTECTIVE ORDER
